- Employee Grievance Update Janet (see Exec. Mintues)
  - This matter will be reviewed by the Policy Committee to make sure employees understand the policy.
- ❖ Have of Hope Lease we have received a signed lease from HRA. Language is as we proposed. This should be finalized at May meeting. Kris will scan and send to all.
- RW Area Homeless Committee Report Jerry
  - This group is not part of HOPE Coalition. HOPE is the financial host. Jack & Diane Nordgaard were active in getting this going. Group tries to raise money to get people off the streets. Homelessness is an increasing issue is Red Wing area. Goals:
  - 1. Immediately get people off street JoAnn is key contact person. Anyone can refer to JoAnn. She puts people up at local hotel. Last year paid for 300+ nights. Raised \$15,000-\$18,000 per year; mostly from private donations and churches. 25% goes to HOPE as fiscal sponsor (helps cover JoAnn's salary)
  - 2. Raise community awareness.
  - 3. Possibly build a shelter. Have not found a location. Run into zoning issues.

Those involved: Jerry O'Rourke (Chair), Jack Norgard, Dennis Koenig, Jim Magnuson, JoAnn McNamara, Connie Miller, Christie Dickenson, Beth Breden.

Have received commitment from City of Red Wing to pay \$20,000 annually for 4 years. To date, \$10,000 has been received.
