This last year has been a year of growth for HOPE Coalition. We grew in locations we served, we expanded community events along with our education activities and ultimately the number of people we served. We saw over 40% growth in the number of people that HOPE advocates supported from

recent years. With support from our funders and community partners as well as enthusiasm from staff, we were able to grow our programs. We experienced so much growth in Wabasha it necessitated a move to a larger office

(see right). We also expanded our services to youth by adding an advocate within the Red Wing schools, in addition to our presence in Cannon Falls. I am pleased to say we strengthened our relationships with our community partners, allowing for better wrap around services for victims of violence. This means together we have a much better chance of breaking generational cycles of abuse. HOPE is going into its 32nd year of service to the community. Story of HOPE

Allison had been caught in a cycle of abuse since childhood. She was conditioned to believe all the abuse she experiences was her fault. Some of the abuse she endured included getting drugged and sexually assaulted. She continued to be harassed and intimidated by the perpetrator. She found HOPE Coalition and worked closely with an Outreach Advocate. She gained the courage to file for a Harassment Restraining Order (HRO); even though she was terrified to present her case before a judge, our advocate stayed with her during the entire court process. The judge believed Allison and she was granted the HRO. "I can breathe now. I can't thank you enough for helping me, thank you for believing me."
